Seminar On Mahila Suraksha Nitti

Drishti NGO with Sampurna organized a seminar on Mahila Suraksha Nitti at 10th May 2014 at Speaker Hall, Constitution Club, Rafi Marg, New Delhi. It was attended by various women leaders across the board. The first speaker Dr Kiran Bedi, Former IPS Officer, defined 6 Ps' to control crime. In the august gathering Ms Bedi suggested that first of all we — as parents, principal, people and neighbors — should understand our duties and take action even before the crime takes place. If we do our duties properly, we can prevent crime in one way or the other. The other Ps' i.e., Police, Politician, Prosecution, Prisons and Press are also effective tools to control crime. Smriti Irani, M.P. Rajya Sabha, in her impressive speech said that the designated amount in Nirbhaya fund of Rs 209 Crores was not spent on the rehabilitation of the rape victims. While answering the questions of participants, she said that Broadcaster Association of India is the competent authority to make a complaint against the indecent advertisements or statements. Madhvi Diwan,

Advocate Supreme Court discussed the legal aspects of various Acts for empowering women.

Dr. Shobha Vijender said that 10th May should be observed as the Women Security Day. Referring to the existing Criminal Justice System, she said that in the current times, women of India need security as the first step in their welfare on the path to empowerment. Institutions should be held accountable for any laxity in the system. The Civil Society needs to play an effective role in making the system workable. The valedictory speech was given by Geeta Gunde, National Convener, Mahila Samanvay who said that the seminar in New Delhi would be a milestone towards a National Policy on women security.

Mrs. Taruna Kataria, President, greeted the members present in the AGM on behalf of Sampurna. She apprised the members about the activities of Sampurna inside and outside Delhi. She said that the volunteers of Sampurna were continuously holding programs in other parts of India, keeping in view the need of such programs to aware the people on social issues. She strongly felt that under the noble guidance of Dr Shobha Vijender, Founder President, Sampurna should register itself as a National Organization. All the members unanimously agreed to it and **Resolution was passed** to amend the Memorandum of Association of Sampurna, page no 25/C, point 9 to make the Society namely "Sampurna" under Societies Registration Act 1860 as applicable to the India as a whole in pursuance of the Memorandum of Association of the Society. The Coordinator of Sampurna Ms Tanvi Grover and Krishan Lal Minocha were assigned the duty to complete all the necessary formalities to register. Taruna Kataria further requested them to complete the registration process within 10 days so that new branches may be initiated in other parts of India. The President then declared that on 8th Nov 2014, another meeting will take place regarding the Amendment. All the members agreed to it.

Press Conference by Sampurna on 'Juvenile Justice System in India and its Challenges' Seminar

A press conference was organized by Sampurna at Constitution Club, New Delhi regarding seminar on 'Juvenile Justice System in India and its Challenges' to be held at NDMC Convention Hall, Opp. Jantar Mantar, New Delhi on 10thOctober, 2014. The conference was attended by all the leading newspapers and electronic media. Juvenile Justice System is one of the most challenging and sensitive aspect of contemporary Indian society. According to Dr. Shobha Vijender, Founder President of Sampurna, a law is enacted to act as a deterrent as well as to reform. However today our Juvenile Justice Act, 2000 is unable to serve any of the purposes and day by day crimes by juvenile and crimes against children are rising unfettered across the country. As per Dr. Shobha there is an urgent need to review all the laws which have a direct bearing upon protection and care of children and they must be amended in the light of contemporary social settings. Media was apprised of this as well as the topics to be contemplated upon in the seminar. The main topics were:

- 1. Challenges of 21st Century under the Umbrella of J.J. Act, 2000
- 2. Emerging New Trends: Crime for fun by Juveniles
- 3. Best Practices in Children Home under the light of POCSO Act, 2012
- 4. Role of Social values in the Control and Prevention of Juvenile Delinquency

The Seminar would be attended by Academicians, Students, Social Workers and Law Makers from across the country. The inauguration of the seminar would be done by Hon'ble Minister of Law & Justice, Govt. of India, Shri Ravi Shankar Prasad. The parents of missing child 'Jahnvi' were also present in the press conference. Dr. Aradhna Sharma, Harjinder Kaur and Madhu Das were also present.

Seminar On 'Juvenile Justice System In India' Organized By Sampurna

Sampurna organized a seminar on Juvenile Justice System in India in New Delhi. "Constitution provides welfare and rights of dignified living, without fear to all the citizens including children", said Shri Ravi Shankar Prasad, the Hon'ble Minister of Law and Justice, Govt. of India, while inaugurating the seminar in Delhi. In august gathering present there, he said that the Government is open to hear to all kinds of school of thoughts regarding the age of the Juveniles. In his deliberations he said that the Government, led by Hon'ble Prime Minister Narendra Modi, is very sensitive towards the rights of children. The Juvenile Justice System could be improved by using the modern technology. The missing children could be traced in less time through portal. Targeting the youth, sitting in large number there, he said that now global information is one click away. He appreciated the good work done by Sampurna from last several years.

The Founder President of Sampurna Dr Shobha Vijender, while addressing the press, said that the organization is trying to bring the policy makers, bureaucrats, academicians and general public on common platform to synergize the existing laws involving Juveniles. She further said that the need for the seminar had arisen as a number of proposals were being received pertaining to amendments in 'Juvenile Justice Act 2000' from the experts who have been constantly trying to bring a change in the pathetic conditions of children within the institutions and outside. She raised

the issue of escalation in number of crimes committed by Juveniles. As per the latest data of National Crime Records Bureau, the involvement of Juveniles in cases of rape in the capital shot up by 158% in 2013 (163 cases) as against 2012 (63). It revealed that the involvement of juveniles in crimes as well as crime against children was on the rise unfettered and administration seems to be almost helpless. The children were victimized and they were being used to commit crimes. In both the situations children are the sufferers. The existing Juvenile Justice Act talks in length about the care and protection of children till the child attains the age of 18. But in real settings, the Juveniles are exploited, abused, molested and exposed to criminogenic environment more often to become delinquent. The case of Nirbhaya rape had awakened the collective conscience of the nation against the crimes committed by a Juvenile.

Amod Kanth, ex-police officer, was of the view that the Juveniles are juveniles and any attempt to reduce the age of culpability may be unfortunate. He emphasized to provide moral and professional education in the children homes to rehabilitate them in society.

Vartika Nanda, senior journalist, was of the opinion that the laws involving Juveniles need to be understood in the new perspective of 21st century. Also, the Press should not down play the violations of the Juveniles.

Dr Aradhana Sharma, psychologist, explained in detail about the multiple causative factors theory responsible for forming the personality of the child. According to her, in the 21st century, children are exposed to invasions through the sky and there is also a lack of social control.

Professor Gargesh, in his session, said that the present Juvenile Justice System had provisions of sponsorships and foster care but there is no implementation. The usage of language by Juveniles needs to be cultured.

The other distinguished panelists of the seminar were Mamta Sahai, Member, Delhi Commission for Protection of Child Rights, Dr. Vishal Chhabra, Psychiatrist and Deaddiction Specialist, A.C.P, O.P. Arora, Special unit for Women and Children, Avinash Jain, Founder, Sweet Home, Vishwajeet Ghoshal, Director, Prayas NGO, Nidhi Mutreja, Assistant Professor of Law, VIPS. During the brain storming sessions in the full day seminar, the following were the main points that emerged:

1) To bring a synergy in the existing laws relating to juveniles.

2) Immediate action should be taken by the police and to lodge the FIR in no time.

3) Human trafficking should be stopped.

4) Criminal justice functionaries should use the latest technology to control crime.

5) School Education should be relevant, workable and inclusive.

6) Parenting should be emphasized.

The certificates were distributed to the participants in the end.

Research Done By Sampurna On The Crime Reported In CIC

Sampurna held a press conference at Constitution Club, New Delhi to report the sexual offences reported in Crisis Intervention Centre, Sampurna North West, Delhi during the last six months starting from April 2014 to September 2014. The social scientists sharing the stage discussed conducive variables, conditions and circumstances of both the accused and the victims. Dr Shobha Vijender, founder of Sampurna said that the ground level study was done by the counselors in CIC. Sampurna has been working for the victims of abuse and rape in North West District of Delhi for the last several years. The report aims to draw the inferences for the better functioning of the FCC. After Nirbhaya incident, the general population is keen to know the causative factors in commission of crime against women. The popular literature is full of stories. Hence Sampurna conducted the research taking into account the crime reported to CIC last six months.

The data analysis reveals that both, the accused and the victims, belong to very humble background. Findings of the study reveal that 11-17 years is the most vulnerable age group for sexual crimes as 46% of rape cases are reported in this

group. School going children are more prone to sexual assaults. Children living in poverty-stricken households in slum areas are most susceptible to sexual violence.

In 94.7% of adult cases, accused is known to victims or is their close confidante. The economic status of accused does not reduce their susceptibility to commit crime. However, in case of children, economic and educational background of the accused does not work as deterrence. Study also reveals that accused belong to 18-40 age group in majority of the cases, irrespective of age of victims.

Dr Shobha Vijender says that the research study brings many unsaid stories. There is an urgent need for social scientists, media persons, criminal justice functionaries and society at large to ponder upon the fact that in this transitional phase of society, many norms are breaking. It also reflects that the present system of controlling crime against women needs to be revamped completely. Keeping in view the deterioration in social and moral values, the present matrix of society has changed. Men should be trained, guided and directed to treat women as a human being and who is at par with them.

Rashmi Singh, former Director Mission Convergence, Amod Kanth, General Secretary Prayas and Vartika Nanda, Journalist, also gave their suggestions. The press conference was well attended by the Media persons English & Hindi leading News Papers, Free Lancers and College Students.
